This program is designed to be completed in 1,000 clock hours / 30 weeks by a student attending full time. Student must hold a current Oklahoma Cosmetology or Barber license.

The direct costs for this program are **\$2,000 for tuition, \$50 application/initial fee, and \$500 for books, course materials, supplies, and equipment, and a \$35 certification exam fee for licensure** for an in-district student if completed within normal time. The indirect costs are listed below:

#### Independent Student

Living Expenses: \$11,925.00  
Transportation: \$ 2,583.75  
Miscellaneous: \$ 5,366.25

#### Dependent Student

Living Expenses: \$ 5,654.40  
Transportation: \$ 1,225.12  
Miscellaneous: \$ 2,544.48
