Northwest Technology Center (NWTC) Fairview Campus will begin accepting applications for the Cosmetology Program on February 3, 2025. **Your enrollment in the Cosmetology Program cannot be considered until all items are received and you and a parent/guardian have attended a Mandatory Orientation Meeting. Applications are due March 3, 2025.**

- _____ **\$12 Application Fee** – This fee is non-refundable. Cash or checks payable to NWTC.
- _____ **NWTC Application for Enrollment**
- _____ **Cosmetology Entrance Questionnaire**
- _____ **Student Contract/Agreement** – Read and **initial** each statement to demonstrate understanding and agreement to comply.
- _____ **Copy of your Original Birth Certificate, Driver’s License or State Issued ID** – This document is required for OSBCB and must be valid through August 30. Student must also provide documentation of name change if current name and birth certificate, driver’s license, or state issued ID do not match.
- _____ **Copy of your high school transcript documenting passing grades in all course-related subjects.** (OSBCB, 59-199.7G1-2, p64) If you have a GED, please provide a copy of your incomplete high school transcript and a copy of your GED.
- _____ **Copy of High School Attendance Summary** - from 9th grade to present.
- _____ **Papers of adoption or marriage license** – *Only required if your name is different than the one on your birth certificate, driver’s license or state issued ID.
- _____ **Documentation of Transfer Hours** – *Only required if student has previously been enrolled in a Cosmetology program
- _____ **Attend Mandatory Orientation Meeting – March 5, 2025 - 6:00pm – 6:30pm**
Your photo will be taken for the OSBCB Registration Form. If you are unable to attend on this date, call 580-227-3708 to make arrangements with Mr. Shaw. **Your application will not be considered if you do not attend a meeting.**
- _____ **OSBCB Student Registration Form** – This form will be completed at the Orientation Meeting. **You will need to know your social security number.**
- _____ **Date scheduled to WorkKeys test** – This is a requirement for entrance into the program. Call NWTC at 580-227-3708 to schedule. Mrs. Kay Koehn will be offering testing dates May 23 - 30.

- * Clear copies and easily read
- * Submitted to NWTC in the English language
- * Turned in to NWTC **BEFORE** the Mandatory Orientation Meeting
- * **Priority will be given to those who have turned in a completed application and attended the mandatory orientation meeting**

Student Contract/Agreement

Applicant: Read and initial each statement below to demonstrate understanding and agreement to comply.

- I will not be offered a spot in the class until all documents have been submitted and all requirements have been fulfilled. Failure to complete all necessary requirements could result in a cancelled application or removal from class.
- I must wear the proper uniform and shoes which are required for training in NWTC’s cosmetology program. I am not allowed to clock-in to receive cosmetology training hours until I am in the required uniform. (OSBCB rule 175:10-3-64).
- I understand that I must adequately progress in my coursework and hours of completion in order to return each semester. My allowed absences may differ than that of NWTC policy.
- **HIGH SCHOOL ONLY:** As a high school student, I must complete 1000 Cosmetology hours of training @ NWTC plus 500 hours of related high school subjects as deemed by OSBCB (OSBCB rule 199.7G1-2, p68) in order to register to take the OSBCB Licensing Exam. I am limited to 4 semesters in NWTC’s Cosmetology program. In 4 semesters, I will have more than enough time to complete the 1000 required hours. If I do not complete my training in 4 semesters, I will need to seek Cosmetology training opportunities elsewhere and add 500 hours.
- **ADULTS ONLY:** As an adult student, I must complete 1500 Cosmetology hours of training @ NWTC in order to register to take the OSBCB Licensing Exam. I am limited to 4 semesters in NWTC’s Cosmetology program. In 4 semesters, I will have more than enough time to complete the 1500 required hours. If I do not complete my training in 4 semesters, I will need to seek Cosmetology training opportunities elsewhere.
